Notice Concerning Structural Reforms and Changes of Directors

SCSK Corporation (Head Office: Koto-ku, Tokyo; Representative Director, President and Chief Operating Officer: Toru Tanihara; hereinafter "SCSK") announced the structural reforms and the changes of Directors, which was resolved at the Board of Directors meeting held on January 31, 2022, as detailed below. 1. Outline of Structural Reforms

Given that fiscal 2022 is the final year of the current medium-term management plan "SCSK Group Medium-Term Management Plan (FY2020 to FY2022)," the current organizational structure will be continued in principle and some reorganizations will be made.

- Establish Resource Strategy Center to further promote the expansion and optimal use of personnel resources.
